DUE DATE

Your current charges are due and payable by the due date shown on this statement. A 3% late payment fee will be applied to bills not paid within 20 days of issuance.

POWER COST ADJUSTMENT CLAUSE (PCA)

The PCA provides monthly adjustment of power costs relative to base rates. This adjustment can be positive or negative, which will increase or decrease your monthly energy costs. This ensures you get charged the actual cost of energy consumed.

CP1 ENERGY LIMITER: \$0.1514 PER KWH

Monthly, the customer shall be billed the lesser of 1) the amount of the Energy Limiter or 2) the amount for the Energy Charge plus the amount of the Demand Charge.

STORM WATER CHARGE

This is a City charge for storm water runoff of the impervious area of your property. Call City of Sun Prairie Engineering at 608-837-3050 if questions.

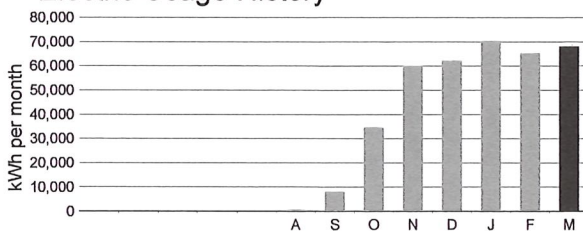

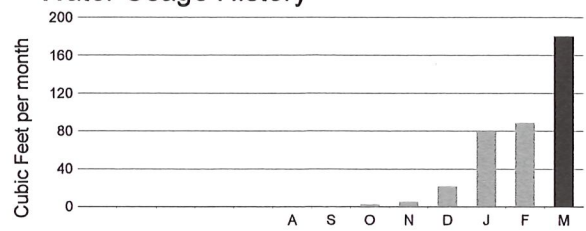

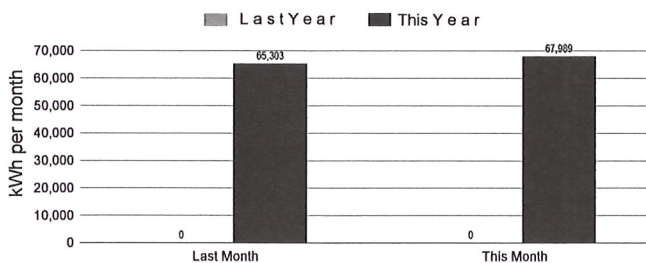
Electric Usage History



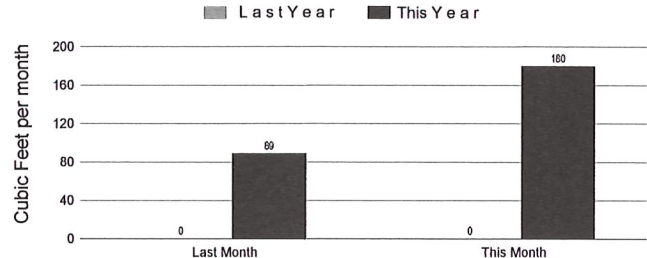
Water Usage History
